**To find your precinct:**

Go to the Summit County Clerk Website.  
Click to the left on “Voter Registration and Elections “.  
Click on the “Interactive Voter Map”.



Enter address top right.  
See your property parcel # and address.  
Click forward arrow to find precinct, school district, congress/senate/house districts and other info.

**To access your sample ballot:**

Go to the Summit County Clerk Website.  
Click to the left on “Voter Registration and Elections”.  
Scroll down to “Sample Ballots”.  
Click on your affiliation (e.g. Republican).  
Click on your precinct. Your yellow sample ballot will appear.
